a. Overall Work Program FY2021 Revision #1

The Overall Work Program (OWP) is OahuMPO’s annual budget and schedule of planning studies to be completed over a specified time period. Revision #1 to the Overall Work Program FY2021 is an amendment that proposes adding the Work Where You Live study and the Congestion & Mobility Pricing Study. The proposed budgets for these studies are \$100,000 and \$860,000, respectively. The City and County of Honolulu will provide the local match for both work elements.

Requested Action: Recommend Policy Board Approval of Revision #1 to the OWP FY2021, as presented.
