ORTP 2045 UPDATES

Conclusion of Community Outreach: Community Meeting and Intergovernmental Review Overview

During the month of March, OahuMPO co-hosted seven community meetings with representatives from the Hawaii Department of Transportation, City and County of Honolulu Department of Transportation Services, and the Honolulu Authority for Rapid Transit, along with city councilmembers. The goal of these sessions was to provide an opportunity for community members to ask agency sponsors questions regarding the ORTP 2045 proposed transportation projects and programs with an elected representative present to hear comments and concerns. OahuMPO also concluded its intergovernmental review period for the 2045 O'ahu Regional Transportation Plan (ORTP) that was held from March 1-29, 2021. Keeaumoku Complete Streets

The City and County of Honolulu is starting a Complete Streets project for Keeaumoku Street. Keeaumoku Street provides a critical mauka-makai connection between Makiki and Ala Moana, serving many residents and businesses. The purpose of this project is to transform Keeaumoku Street into a Complete Street, as required by the City's Complete Street ordinance (ROH-13-33), with a street design that balances the needs of people of all ages and abilities whether they are walking, using a wheelchair, riding a bike, riding transit, or driving a car. We need your help to ensure that the project addresses the needs and desires of the neighborhoods and destinations it serves.
