3. APPROVAL OF THE OCTOBER 7, 2020 AND NOVEMBER 4, 2020 MEETING MINUTES

Chair Shigemasa moved to approve the October 7^{th} and November 4^{th} 2020 meeting minutes. There were no further discussions, abstentions, or objections and the minutes were approved as presented.

6. NEW BUSINESS

A. 2045 ORTP Short-Range DTS Project and Program Submissions, Evaluation and Scoring

Transportation Planner, Kiana Otsuka presented an overview of the nineteen projects and programs submitted by the City and County of Honolulu Department of Transportation Services for consideration for short-range Federal transportation funding, along with the evaluation and scoring of new projects. For each of the two new projects, the description, cost, applicable goals and objectives, and evaluation score was presented.

In addition, Kiana shared an analysis of the project and program primary objectives versus the weights assigned to each objective in the prioritization process for all projects submitted for consideration for funding, as well as a list showing how all new projects rank compared to one another.

No questions were asked, and there was no discussion.

B. 2020 Congestion Management Process Report (CMP)

Senior Transportation Planner, Zakari Mumuni explained that the purpose of a CMP is to identify the process for collecting congestion related data, develop performance measures used to report congestion data to the public, and guide funding toward projects and strategies which most effectively address congestion. Zakari noted that the CMP is federally mandated process that provides for safe and effective integrated management and operation of the multimodal transportation system. Part of the Federally mandated process is the following eight steps:

- 1. Regional Objectives for Congestion Management
- 2. CMP Network
- 3. CMP Multi-modal Performance Measures
- 4. Data to Monitor System Performance
- 5. Congestion Problems and Needs
- 6. Congestion Management Strategies
- 7. Implementing CMP Strategies
- 8. CMP Strategy Effectiveness

Zakari then reviewed each of the eight steps, and the supporting data to demonstrate that the MPO has met its federal requirements.

There was discussion about the reduction of public transit ridership and whether there were any plans to make riding TheBus more attractive. There was discussion about the upward trend of pedestrian and bicyclist deaths, and how to use the data collected to inform policies to reduce those deaths.

C. ORTP 2045 Existing and Forecasted Conditions Chapter Preview

Senior Transportation Planner, Zakari Mumuni presented an overview of the Existing and Forecasted Conditions Chapter for the 2045 Oahu Regional Transportation Plan. Information presented ranged from socio-economic, commuting, and employment data, as well as information about our existing transportation system. Zakari explained that this information is used to inform the selection of projects and programs for the 2045 ORTP.

No questions were asked, and there was no discussion.
